#### PALLIATIVE CARE

Palliative care is specialized medical care provided for patients with serious or life-limiting illness, including chronic and progressive neurological conditions such as dementia or Parkinson's Disease.

#### What is palliative care?

- Palliative care aims to improve quality of life, provides an extra layer of support that compliments ongoing care and facilitates a goals of care discussion for patients and families.
- Palliative care is provided by a team of specially trained medical professionals such as a nurse practitioner and registered nurses.
- Palliative care is a health care benefit available to patients through their insurance. It does not replace primary care or treatment of a serious illness, but instead the palliative care team works together with a person's primary care team to provide additional oversight, management and support.

#### Who is eligible for palliative care?

 Palliative care is available to patients with advanced chronic illness, regardless of their treatment status. Palliative care can begin at any stage of the illness and continue throughout the disease process. Palliative care is sometimes seen as a bridge to hospice.

#### How is palliative care different from hospice care?

Palliative care and hospice care fall under the same umbrella and are
usually provided by the same organization. Unlike hospice, palliative
care is not time limited and can be used while a person is still receiving
curative treatments for their illness. The focus is on managing many
symptoms associated with their illness such as pain, nervousness, sadness,
difficulties with sleep and appetite, etc.
